

PRIVACY STATEMENT

ALG Associates, LLC (“ALG Associates”) operates a website under www.WarrantyConference.com and has created this privacy policy to demonstrate its commitment to the privacy of the users of our web site. ALG Associates, LLC uses an integrated SSL certificate for secure transaction security procedures to protect personal information of users. ALG Associates LLC uses Security Metrics to ensure PCI compliance.

Collection and Use of Non-Personal Information

ALG Associates, LLC automatically receives and records non-personal information on our server logs from your browser including your IP address, cookie information and the page you requested. ALG Associates, LLC may use this information to customize your on-line experience and to fulfill your requests for certain products and services. However, ALG Associates does not connect this non-personal data to any personal information collected from you.

Log Files

Most web sites use log files.
